

# Terms and conditions

## **Conclusion of contract / Right to cancellation**

As the number of participants is limited, registrations are processed in the order of reception. In case of a successful registration via the online form a confirmation email with the invoice details will be sent. We point out the statutory right to cancel the contract within 14 days.

In case of a registration via letter or email the signed registration form (to be included in original resp. as scan/foto) is the only binding form of registration. A confirmation will not be sent.

The total sum has to be transferred within two weeks.

Participants from non-EU states are eligible to pay cash at the start of the event to avoid unnecessary fees.

## **Reservation of changes in the schedule / Official language**

We reserve the right to change the schedule due to the size of the event.

The official language of the event is English.

## **Declaration of self-responsibility**

With the registration I declare myself physically fit to take part in the event and that I am prepared to act self-responsibly.

I commit myself to take personal responsibility for any damages I may cause.

## **Image rights**

I am aware that there will be video recordings and foto shoots during the event. With the registration I expressly agree to be filmed and that the producers / the organizer can publish these images for documentation and advertising purposes which are related to the Chinese arts and on the websites of the Taiji Forum, the Push Hands Meeting and the Tai Chi Studio. ## **Withdrawal**

In case of a withdrawal up to 6 weeks before the event, a processing fee of 50,- Euro will be charged. Thereafter the full sum will be retained resp. requested by the organizer. The participant is eligible to provide a substitute person.
